However, a new medel for determing which programs to fund was implemented in 2010. Funding decisions are now based on a set of target outcomes which are identified through a comprehensive community participation process. Working in the areas of education, income and health teams of community volunteers review applications for support and recommend specific amounts of program funding based on criteria that includes alignment with desired outcomes, program quality, program outcomes and the impact of out funding. We ask how much each program is doing, how well is being done and if anyone is better off as a result of participating in the program.
