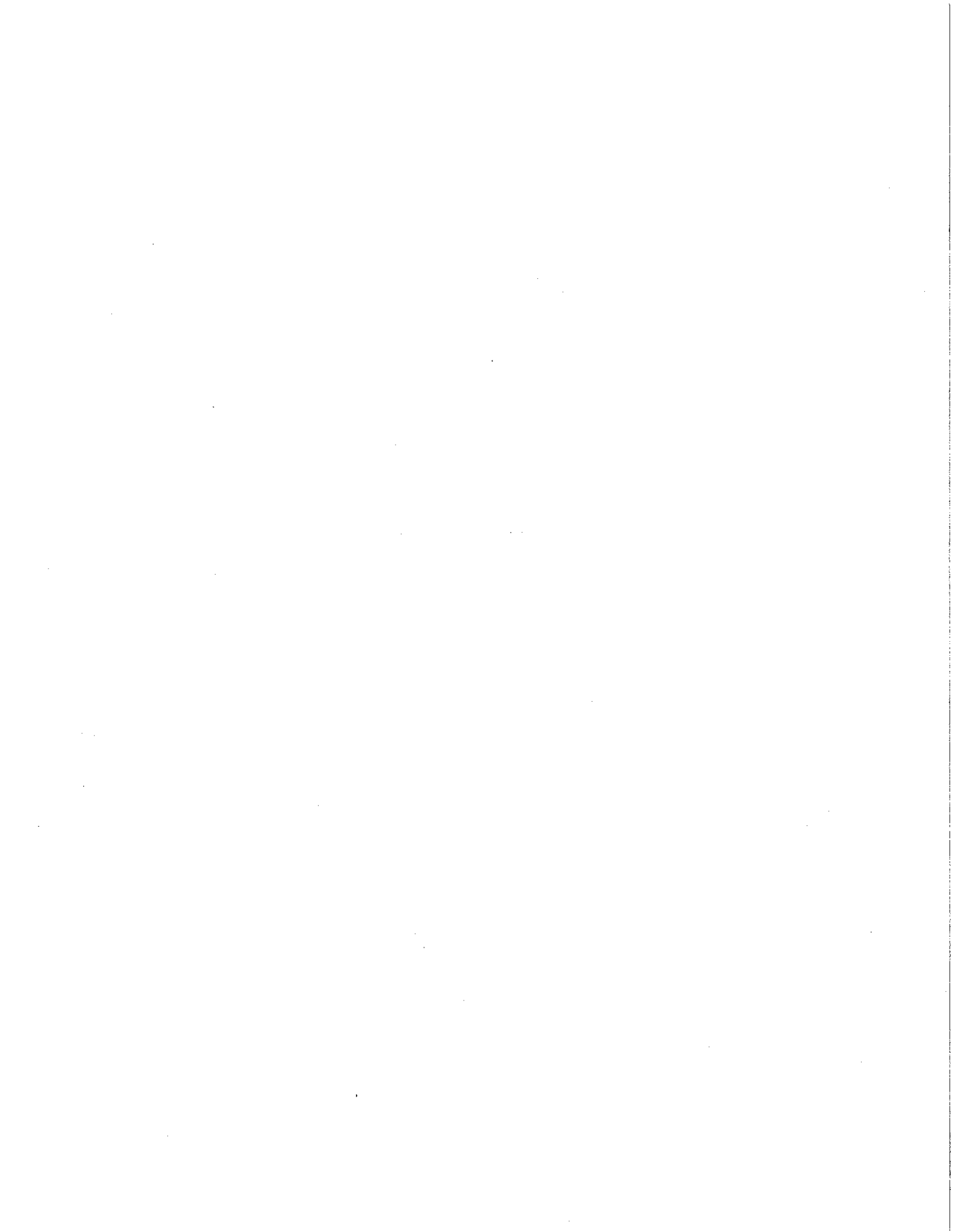

In addition, applicants for funding provide a complete set of current financial statements which are reviewed by local volunteers. Funding recommendations made by the HOPE teams are reviewed by volunteer oversight Community Investment Committee that looks at the entire portfolio of program investment recommendations before furthering the recommendations on to the United Way of Windham County Board of Directors for final approval. Midway through the fiscal year, the Community Impact Teams also make monitoring site visits and/or review reports from the funded programs and ask a standard of questions on how the funds are being used. The organizations also need to complete a progress report in February of the funding cycle and a final report in August, at the end of the funding cycle.
